Paul’s words reflect the tension believers face as they strive to live in accordance with their new identity in Christ, while battling the remnants of their old nature.

The harmony between justification and sanctification is exemplified in the life of Abraham. In Genesis 15:6, Abraham believed God, and it was counted to him as righteousness—a depiction of justification. Yet, in Genesis 22, we witness his faith manifesting in obedience, even to the point of being willing to sacrifice his son Isaac—a portrayal of sanctification through obedience.

In sum, the biblical foundation of justification and sanctification underpins the believer’s journey. Justification stands as the cornerstone of our faith, a result of

Christ's work on the cross. Sanctification, nurtured by the Holy Spirit, represents our ongoing transformation into Christ's image. The distinction between the two maintains a balanced view of salvation—one that acknowledges the gift of righteousness while actively pursuing a life of holiness and growth.

Galatians 4:19 Unveiled: The Heart of Spiritual Transformation

therefore what is earthly in you: sexual immorality, impurity, passion, evil desire, and covetousness, which is idolatry.”

Mortification extends beyond the surface-level suppression of sinful actions; it addresses the root causes—the desires and affections that fuel sinful behavior. As believers engage in the process of mortification, they grapple with their innermost struggles, acknowledging their vulnerabilities and relying on the transformative power of the Holy Spirit. Moreover, mortification is not an isolated endeavor; it is intertwined with the broader themes of community and accountability. As believers journey together toward holiness, they

hold each other accountable and provide support in the process of putting sin to death. Hebrews 3:13 underscores this communal aspect: “But exhort one another every day, as long as it is called ‘today,’ that none of you may be hardened by the deceitfulness of sin.”

Therefore, mortification is not a harsh imposition but a liberating pursuit. It liberates believers from the entanglements of sin, enabling them to experience the fullness of life in Christ. It is a transformative process that reflects the harmony of divine grace and human engagement—a testimony to the profound journey of sanctification, where believers partner with the Spirit to become vessels of honor, dedicated to the Master’s use.

VIVIFICATION: While the concept of sanctification involves the deliberate removal of the negative elements of the old self (mortification), it extends beyond this purgation into the realm of “vivification.” Vivification, a term less commonly used but equally profound, encapsulates the dynamic process of nurturing and cultivating the new self—a self adorned with godly virtues and Christ-like qualities.

Sanctification, as depicted in the process of vivification, is a journey of holistic transformation—a transformation that

doesn't stop at the mere removal of sin but encompasses the active growth and development of godliness. This concept aligns beautifully with the apostle Paul's exhortation in Ephesians 4:22-24: "Put off your old self, which belongs to your former manner of life and is corrupt through deceitful desires, and to be renewed in the spirit of your minds, and to put on the new self, created after the likeness of God in true righteousness and holiness."

The imagery of putting on the new self signifies an intentional act of adorning oneself with godly attributes. Just as one selects attire that represents their identity, believers are called to intentionally clothe themselves with virtues that mirror the character of Christ. Colossians 3:10 reinforces this concept: "Put on the new self, which is being renewed in knowledge after the image of its creator."

Vivification is a process that unfolds in the context of a living relationship with Christ.
